

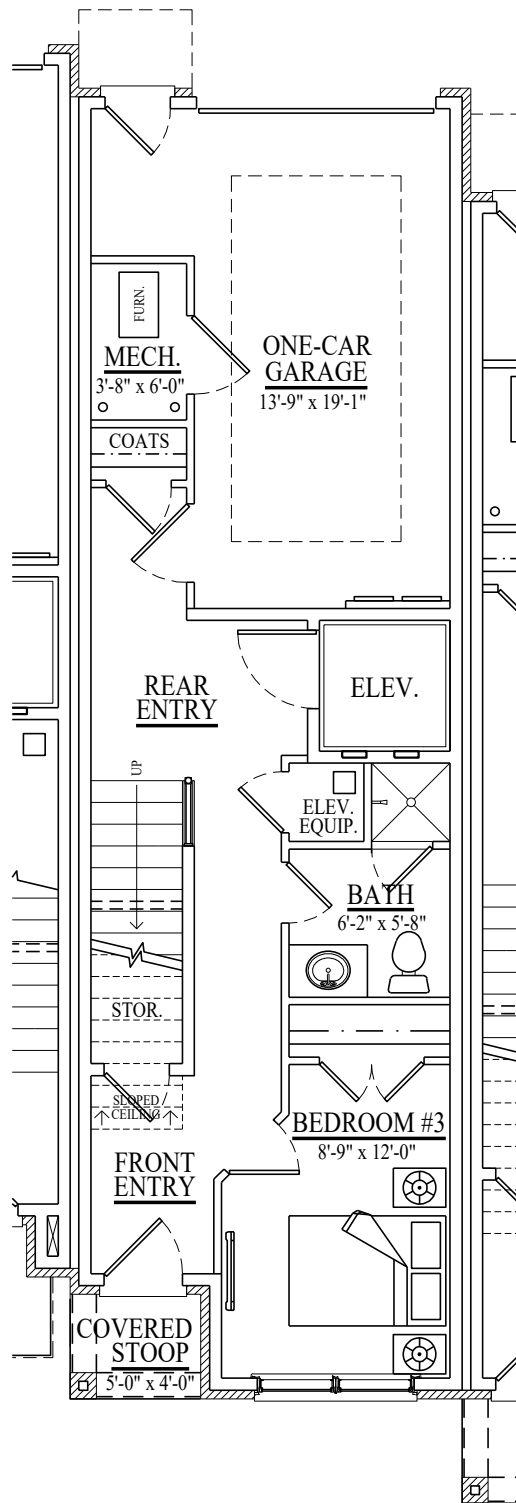

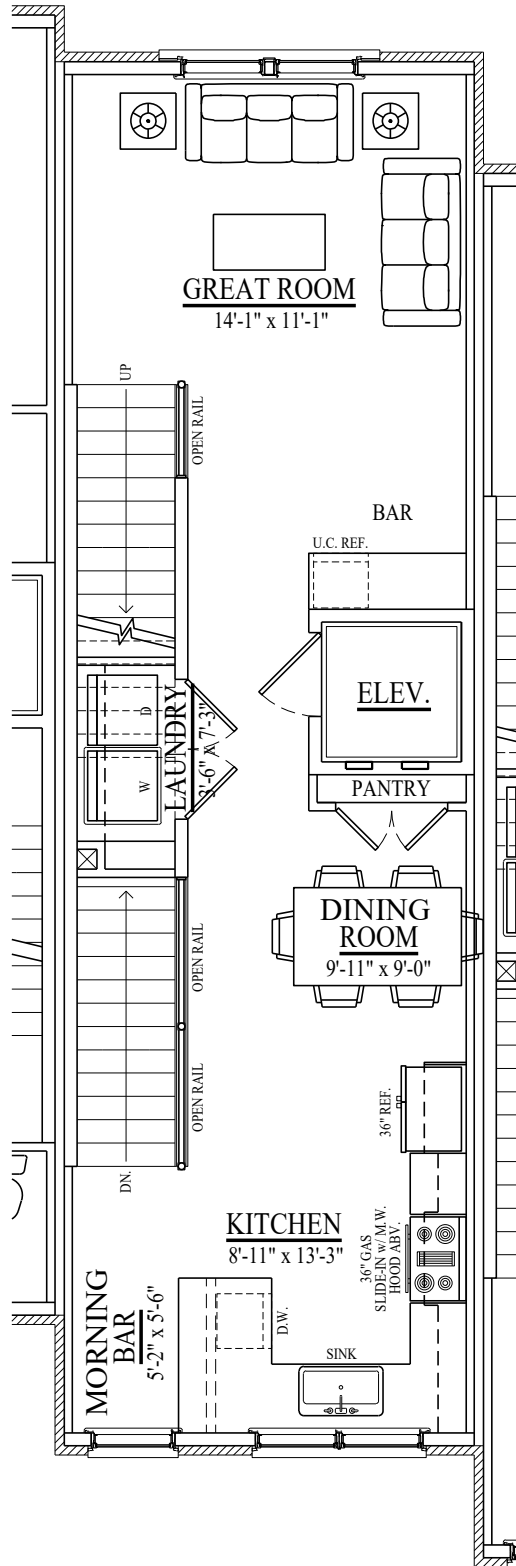
ENTRY LEVEL FLOOR PLAN - Town Home "CE-2" - Interior

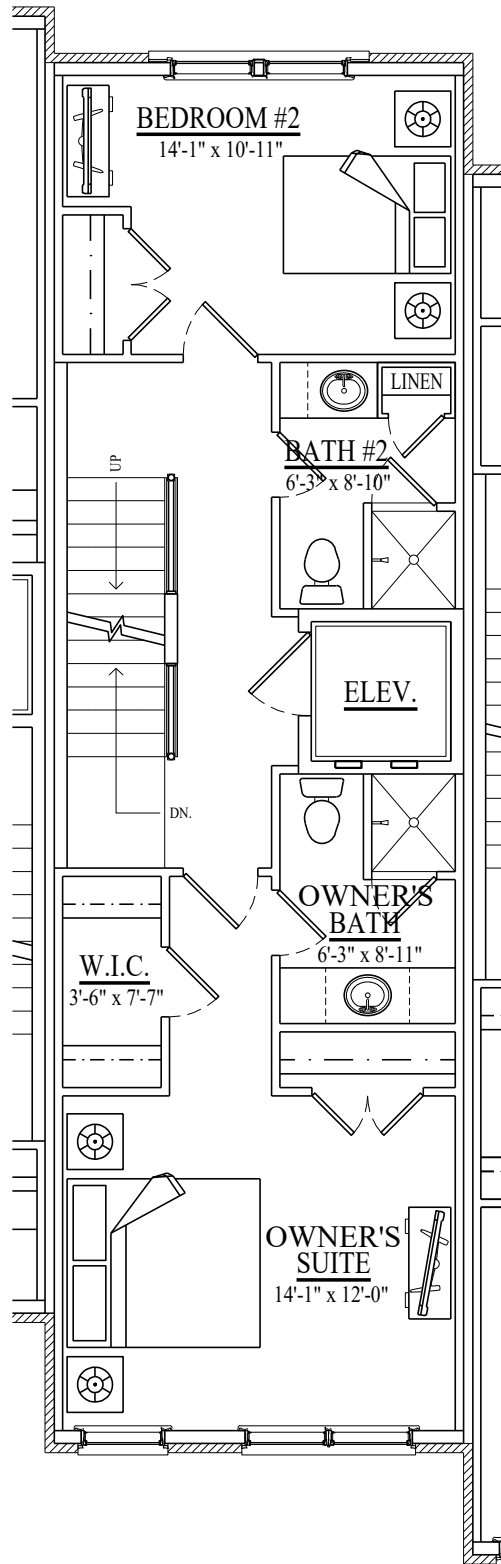

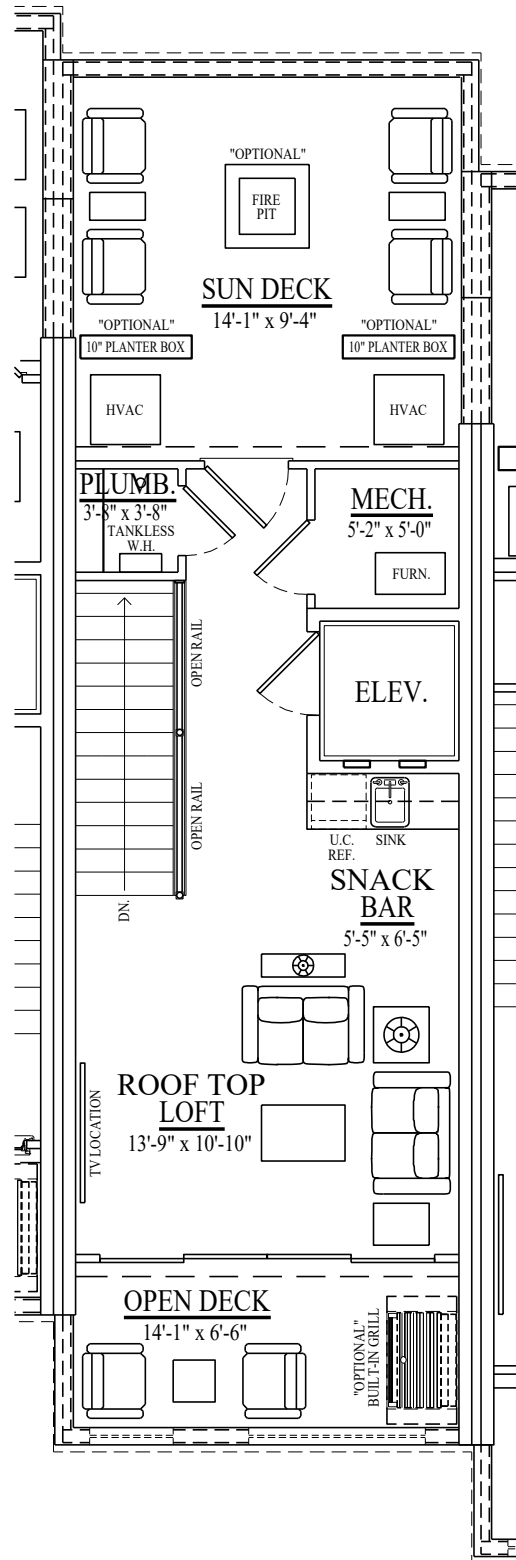
